Police agencies in the State of Texas (including municipal, county, and state) receiving federal grant funding or anticipate applying for federal grant funding must now be “certified” in accordance with Presidential Executive Order 13929 (Executive Order on Safe Policing). Once this form is complete please scan and email it to dojcertification@texaspolicechiefs.org. Incomplete or unsigned forms will NOT be processed. Once this form is accepted, you will receive a Certification Letter via email. This application process will need to be repeated every 3 years.

Colleges and universities must apply to the International Association of Campus Law Enforcement Administrators (IACLEA).

Mandatory Certification Section:

This letter confirms _____ meets certain use-of-force eligibility requirements set forth by the Department of Justice for discretionary federal grants. With this confirmation letter, our agency likewise requests credentials from the Texas Police Chiefs Association Foundation Texas Law Enforcement Best Practices Recognition Program, certifying compliance with the U.S. Department of Justice’s Standards for Certification on Use of Force and Safe Policing for Communities.

I have reviewed the Presidential Executive Order on Safe Policing for Safe Communities, dated June 16, 2020, Executive Order No. 13929 (the “Executive Order on Safe Policing”). I understand that, based on the Executive Order on Safe Policing, the U.S. Department of Justice’s discretionary grant funding is only available to state, local and university or college law enforcement agencies that have obtained credentials certifying they meet certain standards on use of force. I further understand the Executive Order on Safe Policing empowers the U.S. Attorney General to designate independent credentialing bodies to certify that a law enforcement agency meets the conditions of eligibility for federal grants. The U.S. Attorney General has designated the Texas Police Chiefs Association Foundation Texas Law Enforcement Best Practices Recognition Program as an independent credentialing body.

After reviewing the U.S. Department of Justice’s Standards for Certification on Safe Policing for Communities and _____ policies,

I have determined our agency meets the following two **MANDATORY** conditions for certification:

- (initial) **Our agency’s use-of-force policies adhere to all applicable federal, state, and local laws; and**
- (initial) **Our agency maintains use-of-force policies that prohibit the use of choke holds, except in those situations where the use of deadly force is allowed by law.**
