of Safe Call Now, a confidential, comprehensive, 24-hour crisis referral service for public safety employees, all emergency services personnel and their family members nationwide. Safe Call Now was started in 2009 after legislation was passed guaranteeing confidentiality nationwide for all who call the Safe Call Now crisis line that is staffed by current and former first responders. He started his law enforcement career as a San Diego County Deputy Sheriff in 1987 and later relocated to Washington State in 1990. Sean spent over 16 years with the Kirkland Police Department.

Outside of teaching Dr. Ellor has a passion for helping First Responders in crisis. He is EMDR certified and has extensive experience working both in the field and office settings with First Responders, to include Police, Fire, and Paramedics.

Dr. Ellor's credentials include: ACSW, LCSW, Board Certified Diplomat in Clinical Social Work (DCSW), Certified Group Psychotherapist (CGP), Licensed Clinical Professional Counselor (LCPC), CSW-G.

John Allovio started his Law Enforcement career with the Jefferson County, Oklahoma Sheriff's Office in 1994 as a full time DWI Deputy. John started his service to the citizens of Waco, Texas in February 1996 with the Waco Police Department. John has served as a patrol officer, canine handler, narcotics investigator and assisted in the creation of the Lone Star Fugitive Task Force partnering the Waco Police Department with the United States Marshal Service. John promoted to the rank of Sergeant in 2012. As a sergeant, John returned to patrol where he has supervised officers on both midnight and dayshift assignments. John helped to design a seamless, integrated mental health program for first responders and their immediate families that allows for confidential acute care using a combination of employer and private resources resulting in a significant cost savings to those that need assistance.

John holds his Master Peace Officer License and is recognized as an expert in multiple areas of narcotics distribution and delivery. John has been a certified TCOLE instructor since 2009.

John is married to Joy Allovio and has two sons, Christopher and Charlie, both 12.

Sgt. John Allovio will discuss the problems of implementing an acute mental care and substance abuse in patient program that integrates seamlessly into an existing peer support program. Within that discussion topics specifically covered will include:

- Locating a suitable first responder based mental health clearinghouse.
- Ensure that a proper evaluation procedure exists for the acute care facility.
- · Partnering a third party service provider status with city entity.
- Coordination with existing department mental health services (Peer support).
- · Creating a funding source with local non-profits.
- Establishing and integrating local counseling resources for post-acute care patients.
- Creating a knowledge based local counseling system for non-acute mental health services.

Melissa Beseda received her Bachelor's degree in Criminal Justice/Psychology from Tarleton State University in 2011. She has significant experience in aiding victims and officers, and has attended/coordinated numerous services, events and trainings over the last nine years.

In January of 2012, she promoted to Director of the Unit, with the responsibility of supervising unit staff and volunteers.
